Other Options considered to fill the post:

Temporary Promotion was put in place but leaves gap at EOI as no scope for backfill. Interest sought from other 3 branches in pensions Division. Limited scope at SO level and no interest shown. No surplus available. NICSHR previously checked priority pools — with no-one available — may need to recheck,.

Re-distribution of work considered but not appropriate for this post. This is a very small branch working on a high profile policy area with significant new work emanating from a supreme court decision impacting across the public sector so pausing or stopping activities is not an option.

Why it is requested that the post is filled by trawl:

This is a very small branch so experienced staff are essential and the new SO would be required to hit the road running. Posts in this branch at SO, DP and Grade 7 have been filled by trawl in the past when pensions reforms were being introduced. Public Service Pensions policy and legislation is an extremely complex area of work. – The McCloud ruling now requires urgent action to develop new policy for all public sector schemes. This includes working closely with HM Treasury in policy development at a UK level and ensuring that it fits for NI schemes. Depending on the timing for any return of a sitting Assembly, it is very likely that this branch will have to perform the role of a Bill Team to take forward primary legislation. Policy decisions in this area impact the NI budget by hundreds of millions pounds annually. Failure to provide a sound policy and legislative framework for public service pensions in NI, that meets the requirements of the McCloud litigation remedy (once determined by the Employment Tribunal) risks further litigation that could have read across in all public sector schemes. Developments are now moving at a fast pace so a full complement of staff is required.

It would be essential that staff have previous experience in developing briefing in a high profile policy area, taking forward primary and secondary legislation, engaging with a wide range of stakeholders and ideally working experience of a public sector pension scheme. (any sector)
