# Question 2.

Some information you have requested is held by the department but is exempt under Section 21(1) of the Freedom of Information Act. Section 21 applies to

information that is already reasonably accessible to the applicant by other means. Section 21 is an absolute exemption and the department is not required to consider whether the public interest favours disclosure of this information.

This information is included in the 'Recruitment to the NICS Annual Report'. Reports from 2017 – 2022 can be found <u>here</u>.

Please note that Section 22 of the FOI Act (Intended for future publication) has been applied to the 2023 report. It is envisaged that this data will be available in the first quarter of the 2024/25 Financial Year.

By applying Section 22 Exemption of the FOI Act, we are required to carry out a Public Interest Test. This can be found attached as a separate document (Annex B).

### Question 3.

The department holds the information requested; however, portions are being withheld as they are exempt under Section 40(2) of the Freedom of Information Act due to the low number individuals involved. Section 40(2) exempts personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would contravene one of the data protection principles in the General Data Protection Regulations (GDPR) (or certain other provisions of the Data Protection Act 2018). The information requested also falls within the special categories of personal data which requires explicit consent from individuals to process this information.

Having considered all the information contained within the Legitimate Interest Test – also known as a Lawful, Fairness and Transparency Test - (attached as a separate document – Annex C), the department has established that, on balance, there is no lawful basis for the disclosure of third-party personal data falling within the scope of the request of which the requester is not the data subject. Making an unrestricted disclosure of personal data for private interests could constitute a disproportionate and unwarranted level of interference with the individuals' rights and freedoms – particularly their right to privacy and family life under the Human Rights Act 1998.

Where the numbers are less than five, the exact figure cannot be provided as it may identify specific individuals.
